## Course Description from the CS Department Handbook

Covers defining tools of e-business, to understand the manner in which users, tools, needs and opportunities interact. Covers advanced topics of interfacing e-commerce storefronts with backend relational databases, and XML. Includes social, political and ethical issues associated with e-commerce, and business plans for technology ventures. Real world applications and cases are studied to introduce concepts related to the analysis, design, implementation and maintenance of electronic commerce systems. (3 credits)
