GENERAL EDUCATION HUMANITIES RUBRIC

SLOs:

- demonstrate knowledge of the conventions and methods of at least one of the humanities; and
- recognize and analyze nuance and complexity of meaning through critical reflections on text, visual images, or artifacts.

Conventions and methods in the humanities involve the application of an interpretative methodology (use of text analysis, reflective thinking, acknowledgement of audience, etc.) to render something meaningful for others. Close readings of primary and secondary texts; the collection of evidence from primary texts to support an assertion or thesis; and the application of theoretical or analytical frameworks to critically evaluate primary works toward the creation of new information or new perspectives contribute to an appreciation of the meaning and purpose of the human experience. Instructors should have a clear sense of the disciplinary conventions and methods they expect students to know and demonstrate.
