#### A. PROPOSAL DESCRIPTION

## A-1. Describe the proposed project/initiative

The PETE pedagogy lab is in need of a major technology overhaul. Computers in the lab have been recently surplused because they were well beyond their lifetime and updates could no longer be maintained. The PETE major is accreditated by the Council for the Accreditation of Educator Preparation (CAEP). One of the main standards for meeting accreditation mandates is that students have the ability to access and utilize technology in their teaching. In addition, all education majors are required to submit edTPA data to the NYS Department of Education for initial certification. edTPA utilizes technology to record and observe teaching and then analyze that teaching. Our students are at a great disadvantage because of the limited amount of workable technology in the Pedagogy lab in meeting both the CAEP accreditation requirements as well as initial certification requirements. The Department has taken steps to ensure that the lab will be supervised and available to students with the most recent hire of a Lecturer. The next step now is to obtain appropriate lab equipment to support the learning of our students and make Brockport a great place in which to learn.

The proposal aims to address the Strategic Plan - Goal 1

Be a Great College in which to Learn. Specifically, the measure of success we would like to focus on is 3.7 Aim to maintain &, where feasible, expand our accreditations.

The following explains how this proposal will meet the "Measure 3.7" in the Strategic Plan. The Physical Education-Teacher Education (PETE) major is accreditated by the Council for the Accreditation of Educator Preparation (CAEP). Specifically, we have identified each accreditation standard that utilizes technology and the specific component of technology that should be addressed within that standard.

#### Standard 3. Planning and Implementation

Physical education candidates apply content and foundational knowledge to plan and implement developmentally appropriate learning experiences aligned with local, state and/or SHAPE America's National Standards and Grade-Level Outcomes for K-12 Physical Education through the effective use of resources, accommodations and/or modifications, technology and metacognitive strategies to address the diverse needs of all students.

1. Provide students with equipment that can be used to record and visually analyze their peer teaching, field experience teaching and student teaching experiences that can be utilized to develop their instructional plans for PK-12 learners in order to acquire the necessary skills to pass CAEP accreditation Standard 3 Planning and Implementation.

- 2. Provide students with opportunities to visually analyze PK-12 learners motor skill performance derived from field experience teaching and student teaching experiences to develop skills in movement analysis and the ability to provide specific, congruent feedback to enhance student learning and pass CAEP accreditation Standard 4 Instructional Delivery and Management.
- 3. Provide opportunities through the use of technology to help prepare students to develop a Comprehensive School Physical Activity Plan (CSPA) and pass accreditation Standard 6, Professional Responsibility.
- 4. Provide opportunities through the use of technology to help prepare students to develop and refine their NYS Department of Education Certification exam edTPA which requires the submission of a video of a student teaching episode that is fully analyzed by the student.

For the first three goals above, the determination of achievement would be that the PETE major meets the standards related to the technology components for CAEP accreditation. Each will be more fully explained below.

- 1. To meet Standard 3 Planning and Implementation, students will effectively apply content and foundational knowledge to plan and implement developmentally appropriate learning experiences aligned with State and National Standards.
- 2. To meet Standard 4 Instructional Delivery and Management students will develop skills in movement analysis and the ability to provide specific, congruent feedback to enhance student learning
- 3. To meet Standard 6 Professional Responsibility students will develop a Comprehensive School Physical Activity Plan (CSPA) for the school district they are student teaching in.
- 4. To determine if Goal 4 is met, students will submit their edTPA data and obtain a passing score. The PETE major will also post a 90% or higher pass-rate on the edTPA exam each year.

# D-3. Long-term Goals/Objectives:

What measurable long-term goals or objectives (if any) do you hope to achieve with this project in the long-term, meaning beyond the one-year time frame for which funds are available (fiscal year 2019-20)?

Through the use of this technology, our long-term goal is to meet the new 2018 CAEP accreditation standards related to technology on a continuous basis. In addition, our long-term goal is to assist our students to prepare for edTPA submission and to pass this component of the certification exam. The PETE major also needs to maintain a yearly 90% or higher pass-rate long term. Finally, and most importantly, we aim to graduate students who can be effective teachers and have a positive impact on PK-12 learners in physical education.

This proposal is heavily reliant on technology. If approved we will order the necessary equipment immediately and work with LITS to have the equipment installed in a timely manner. We see no problem with meeting the requirement of having all items ordered, received and installed by the start of Fall, 2019 semester if possible or shortly thereafter.

The proposal also includes funding to purchase appropriate seating for students (collaboration tables and chairs). Finally, a subscription to Dartfish is included as that is the main software program used to analyze teaching.
